WHAT TO BRING !

- **Social Security cards** (or ITIN cards or ITIN letter) for all members of the household
- **Picture Identification** for taxpayer and spouse
- **Proof of all income** including W-2 and 1099 forms and self employment records
- **Child Care Information** including record of payment with name, address, and tax ID# of childcare provider
- **Tax Deduction and Credit Information** including mortgage interest statements (Form 1098), medical expenses, tuition payment statements (Form 1098-T), receipts for any property taxes and charitable contributions paid in 2010.
- **Direct Deposit Information** - bank routing and account numbers (voided check)
- **Prior year (2010) tax returns** - bring a copy of your federal and state returns if available
- **Both spouses must sign** if filing jointly. Sorry, no file married filing separately (MFS) returns
